Establishment Of Parking Meter Areas.

[SO2010-4191]

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 200 of the Municipal Code of Chicago, the Director of Revenue is hereby authorized and directed to establish parking meter areas, as follows:

Ward	Location
25	On South Damen Avenue (east side) from West Cullerton Avenue to the first alley south -- rate \$1.25 -- 8:00 A.M. to 9:00 P.M. -- Monday through Sunday (4 meters);
42	At 617 West Fulton Street -- rate \$2.50 -- 8:00 A.M. to 9:00 P.M. -- Monday through Sunday (2 meters);
50	2911 to 2931 West Touhy Avenue -- rate \$1.25 -- 8:00 A.M. to 9:00 P.M. -- Monday through Sunday (13 meters).

SECTION 2. This ordinance shall take effect and be in force hereinafter its passage and publication.

Amendment Of Parking Meters.

[SO2010-4192]

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Repeal parking meters from the 6400 block of North Rockwell Street (both sides) (8 meters) 8:00 A.M. to 9:00 P.M. -- Monday through Sunday (50th Ward).

SECTION 2. This ordinance shall take effect and be in force hereinafter its passage and publication.

ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF CHICAGO


SECTION 1. The Director of Revenue is directed to install parking meters at the following locations:

- W. Touhy Avenue, south side of the street, from N. Sacramento Ave to N. Francisco Ave.

SECTION 2. The Director of Revenue is directed to remove parking meters on:

- 6400 block of N. Rockwell Avenue, both sides of the street

SECTION 3. This ordinance shall be in full force and effect from and after the date of its passage and approval.
